LIABILITY RELEASE AND ASSUMPTION OF RISK AGREEMENT

Please read carefully and fill in all blanks before signing.

I, _____, hereby affirm that I am aware that skin and scuba diving

have inherent risks, which may result in serious injury or death.

I understand that diving with compressed air involves certain inherent risks; decompression sickness, air embolism, or other hyperbaric injury can occur that require treatment in a recompression chamber. I further understand that the open-water diving trips offered by Tierra y Mar, Dive & Tours, S. de R.L de C.V., dba BLUE Project (hereinafter "BLUE Project") may be conducted at sites that are remote, either by time or distance or both, from a recompression chamber. I choose to proceed with dives with Living Underwater in spite of the possible absence of a recompression chamber in proximity to the dive site.

I understand and agree that neither my instructor(s), divemaster(s), boat captain(s), nor BLUE Project, nor any of its respective employees, officers, agents, contractors, or assigns (hereinafter referred to as the "Released Parties"), may be held liable or responsible in any way for any injury, death, or other damages to me or my family, estate, heirs or assigns that may occur as a result of my participation in diving activities with BLUE Project or as a result of the negligence of any party, including the Released Parties, whether passive or active.

I further understand that most scuba diving activities offered by Living Underwater involves transportation by boat, and that boat diving involves inherent risks including, but not limited to, the entry of the boat from a dock during rough water conditions, water entry from the boat during rough water conditions, the shifting or falling of tanks or equipment, sudden or violent boat movement, any of which could cause injury or death. I understand and agree that the Released Parties shall not be held liable or responsible for any damage suffered by my equipment, or any injury that I may suffer while participating in diving activities offered by BLUE Project. I also understand that the Released Parties will handle some or all of my diving equipment, including that equipment I decide to leave on the BLUE Project boat at the conclusion of a day's diving activities. In consideration of being allowed to participate in the diving activities offered by BLUE Project, I hereby personally assume all risks of this diving activity, whether foreseen or unforeseen, that may befall me or my diving equipment while I am a participant in these diving activities.

I further release, exempt, and hold harmless the Released Parties from any claim or lawsuit by me, my family, estate, heirs, or assigns, arising out of my participation in any diving activities offered by BLUE Project, including claims arising during or after the conclusion of my diving activities with BLUE Project.

I also understand that skin diving and scuba diving are physically strenuous activities and that I will be exerting myself during these diving activities, and that if I am injured as a result of a heart attack, panic, hyperventilation, drowning or any other cause, that I expressly assume the risk of said injuries and that I will not hold the Released Parties responsible for the same.

I further state that I am of lawful age and legally competent to sign this liability release, or that I have acquired the written consent of my parent or guardian.

I understand that the terms herein are contractual and not a mere recital, and that I have signed this document of my own free act and with the knowledge that I hereby agree to waive my legal rights. I further agree if any provision of this Agreement is found to be unenforceable or invalid, that provision shall be severed from this Agreement. The remainder of this Agreement will then be construed as though the unenforceable provision had never been contained herein.
